Motion was introduced by Councilman Fletcher, seconded by Councilwoman Stark to pay the bills as warranted and audited.

Motion was carried.

Supervisor Moore introduced Dr. Nina Versaggi and Brian Grills, Project Director, from SUNY/Binghamton. They distributed information and spoke about the study of Battle Hill and its preservation.

Virginia Parrott, Town Historian, stated she was appointed Historian back in 1972 and she is so happy and so thankful to Dr. Versaggi, Mr. Grills, Christine Milligan, Fort Ann American Legion, Fort Ann Town Board and all the others that have been involved with getting this attention and preservation to Battle Hill.

### Public comment opened at 6:22 p.m.

### Public Comment closed at 6:23 p.m.

Supervisor Moore announced that the public hearing for West Fort Ann Firehouse expansion will be rescheduled for February 12, 2018.

Public Hearing to Opt-Out of Section 487 NYS Real Property Tax Law Concerning Tax Exemptions for Certain Energy Systems opened at 6:24 p.m. and closed at 6:25 p.m. with no comments.

**Supervisor's Report:** Supervisor Moore mentioned that the Tax Collector's Office has experienced a lot of activity since December 22, 2017 through December 28, 2017 since under the new 2018 Federal passed law, the \$10,000.00 state and local law cap. Three hundred thirty four (334) people either sent in or stopped into the Town Hall to pay their 2018 taxes in 2017. The Tax Collector advised the Supervisor that she had taken in approximately \$1,400,000.00, which was approximately a \$600,000.00 increase compared to last year at the same time was \$800,000.00 approximately.

Supervisor Moore received a speed limit decrease request from a woman on Mattison Road, closer to the Kingsbury side. The Highway Superintendent stated she would have to go through the same process/steps as people have in the past starting with a petition.

Supervisor Moore stated the Agricultural Stewardship Association published an article on the Battle Hill easement in the Fall Forever Farmland magazine. The publication will be in the Town Clerk's office for anyone wanting to take a look at it or request a copy. It will also be on the Town website <a href="https://www.townoffortannny.com">www.townoffortannny.com</a>

Supervisor Moore stated that Bob Henke will remain the Washington County Board of Supervisor Chairman, John LaPointe will be the Vice Chairman and Dan Shaw, Town of Easton Supervisor, will now be the Washington County Budget Officer. On January 5, 2018 the standing committees were posted and Supervisor Moore is on the following committees: Ag/Planning/Tourism/Community Development, Chair of the Audit, Finance, Health and Human Services, IT, Public Safety and Ad Hoc Trails Committee. Councilwoman Stark also attends the Ad Hoc Trails Committee monthly meeting.

Supervisor Moore advised that a couple of resolutions had passed at Washington County in December and is very pleased to say that he asked for the County to send out Requests for Proposals for Health Insurance Broker and Property & Casualty insurance. There has been approximately \$137,879.00 savings which is a 47% decrease and on the Property & Casualty side NYMIR has agreed to reduce premium by \$84,938.00 which is a 16.4% decrease for 2018.

Councilman Fletcher will chair the cemetery committee which was previously lead by Mr. Varney.

Councilman Hall will be the liason between the Town, American Legion to work on the Battle Hill Master Plan.

Councilwoman Stark and Councilman Hall will work with Joe Loszynski on the Hadlock Shoreline Protection Plan Committee.

Councilman Fletcher wanted to say Happy New Year to everyone.

Councilman Hall stated it's a real honor to be on the Town Board and looking forward to working with everyone for the betterment of Fort Ann.

Councilwoman Stark announced that the Hadlock 5<sup>th</sup> annual Ice Fishing Derby will take place January 20, 2018. All proceeds go towards the Youth of Fort Ann. There will be food and lots of prizes. There will be an ice rescue demonstration at 11:00 a.m.

Councilwoman Stark announced that a couple of weeks ago Washington County had received a \$430,000.00 grant for the trails from Fort Ann and north to Whitehall.

Councilwoman Stark reminded everyone to take a look at the bulletin board at the Town Hall for Senior events and programs that are available through Washington County Office for the Aging.

**Town Clerk's Report** was given for December 2017.

**Highway Superintendent Report**: Been busy; few little small repairs. Supervisor Moore said the Highway Department has done a great job with the roads. Councilman Fletcher stated that the Town roads were in better shape than the State roads.

**Enforcement Officer Report** was given for the month of December 2017.

Historian Report: None

**Lake Hadlock Project Manager**, Joseph Loszynski, emailed a copy of his matters pending from last progress report to the Town Board Member's. A paper copy is on file in the Town Clerk's Office for

anyone who would like a copy. A copy is also out on the town website <a href="www.townoffortannny.com">www.townoffortannny.com</a> Mr. Loszynski stated it was totally unexpected that AIM went out of business 12/31/17. Mr. Loszynski stated he cannot guarantee 35 days of hand harvesting. Mr. Loszynski will forward RFP to Supervisor Moore and Attorney for the Town to review. Mr. Loszynski will provide the Town Clerk with the addresses that the RFP needs to go to and the Town Clerk has permission to advertise in The Post Star.

Councilwoman Stark asked Mr. Loszynski to read #1 of his monthly progress report. The monthly progress report is available on the town website as well as the Lake Hadlock website. Supervisor Moore stated #1 has to do with the newly formed Shoreline Protection Committee made up of Mr. Loszynski, Councilwoman Stark and Councilman Hall. Mr. Loszynski will schedule a meeting date/time with Councilwoman Stark and Councilman Hall.

On motion of Councilwoman Witherell, seconded by Councilman Hall for permission to RFP 2018 hand harvesting. .

Motion was carried.

**Dog Control Report:** paper copy was given to Town Board Member's. Todd wanted to mention that due to the enumeration licenses were up over 200% and that is good from a Public Health standpoint as well as revenue coming into the Town of Fort Ann. He also wanted to mention 100% adoption rate for shelter, which has nothing to do with him but thought it was worth mentioning, since it doesn't appear on his report. Also, he did dog presentation to over 400 students in Kindergarten through 2<sup>nd</sup> grade for Fort Ann Central School and Hudson Falls students.

**Open Public Discussion at 7:10 p.m.** Chad Wilson, 201 County Rte 16, Fort Ann said he had a question for Attorney for the Town and/or Supervisor Moore regarding the bid awarded tonight to The LA Group. There seems to be confusion about the resolution just adopted. Mr. Wilson asked if as a municipality do we have to receive three (3) bids. Supervisor Moore stated that is was advertised in The Post Star. Attorney for the Town referred to the procurement policy.

William Hohmann, Copeland Pond Rd., Fort Ann had a question regarding solar energy on his property. Supervisor Moore stated that in October 2016 the county, town and school all passed resolutions that they would opt out for the solar exemption. Supervisor Moore explained that if it's less than 12k just a permit is needed. If over 12k a site plan review would be needed.

Christine Milligan, 11 West Rd., Fort Ann asked if the town sent out to other companies instead of just running in The Post Star for the Battle Hill Trails master plan. She thought it appeared to be a conflict of interest. Supervisor Moore stated it was only advertised in The Post Star as required. Christine felt that the Town needed to be proactive and mail the RFP to other companies. Christine also asked if the American Legion and Historical Society was going to be included in this process. Supervisor Moore stated that Councilman Hall would be the liason on this to make sure that American Legion and the Historical Society were all communicated with.
