He stated that he enjoyed his position but is looking forward to being able to dedicate more time to the Town, especially with so many new projects underway; Short Term Rental Laws, Repairs to the Old Stone House Library, the new shared highway building (town and county), the Champlain Power Express, Battle Hill, extension of the broadband money connection, and the connection of the current bike trail between Fort Ann and Whitehall.

Councilwoman Witherell – no news to report.

Councilman Sexton stated that in the near future he would be looking into putting together an updated Emergency Management Plan for the Town, and he would be putting together a committee for it.

Councilman Smith- no news to report.

Councilwoman Stark stated that a meeting would be held on Wednesday in regards to the Hadlock Fishing Derby and a decision would be made by Thursday if that would be cancelled or not due to the lack of ice. She thanked Supervisor Hall for all his help with the work he has been doing to get the bike trail connected from Fort Ann to Whitehall, she also stated that they will be working on putting up signage off Route 4 for the bike trail. She spoke about the "Community Connections" newspaper and brought a copy to Town Hall for anyone who is interested. She also stated that if Meals on Wheels is cancelled due to weather that it will be on the local news channels and radios, and also that the Senior Citizen meal program through the county will give seniors ages 60 and older meal vouchers for various restaurants in the area where they can get a meal for only \$4.
