Supervisor Hall stated he had been busy working on the 2024 budget, we have already had our first workshop of the year the second budget workshop will be held on October 19, 2023 at Town Hall at 6PM. He also stated that he had been in contact with Dave Twiss working on the end of year report on Hadlock along with discussing repairs on the harvester.

Supervisor Hall also stated that he wanted to thank Barb Burch for all of her hard work that she has been putting into her new position as planning board secretary- the Planning Board is running much smoother and it is greatly appreciated by all.

He has also been working on getting the bond secured so the Town can move forward with the new highway garage.

Councilwoman Witherell- no news to report.

Councilman Smith stated the harvester will be taken out of Hadlock on Thursday to do repairs. Total weed take for the season was 35,500 pounds, he thanked Dave Twiss and his crew for the successful 2023 season- they did a wonderful job.

Draw down of Hadlock will begin October 16th, 2023.

Town Clerk's Report was given for September 2023.

Town clerk also reported that the credit card machine for the Town Clerks office should be arriving within the next few weeks, this will cost the Town no additional money and will not result in any lost revenue, due to the credit card charges being charged directly to the customer.

Also, the Town has begun upgrading cyber security that will be installed on all computers and we will now have a computer technician who we can call if we have any problems with any town devices. As for short term rentals Granicus has verified the rental properties in Fort Ann and we are now taking the next steps to get all of the online training done- once this is complete, we will have a better idea when our "go live "date will be regarding the accepting of short-term rental permit applications for the 2024 season.

RESOLVED, the Town Board hereby declares their support for Walker Farm's Farmland Protection Implementation Grant application and their pursuit of a perpetual conservation easement on lands owned by Walker Farms LLC; and that the Town Board hereby authorizes and directs the Town Supervisor to execute and send a letter of support for the above referenced Farmland Protection Implementation Grant application.

6:27p.m. Open Public Discussion

Jo-Jo DeVecchi asked why Mary Ryther was advertising that "Boo Town" would be open? Jo-Jo stated she knows that Mary has not met all conditions that were required by the Fort Ann Town Planning Board to open. Supervisor Hall stated that no one can stop Mary from advertising her business.

Jo-Jo stated that many conditions have not been met such as the storm water drainage that needed to be approved by Tom Jarrett (Fort Ann Town Engineer) and that the camper trailer is still on the property. The camper trailer has been attempted to be moved three or four times (according to Mark Miller-Code Enforcer) and due to the ground being too wet it has been unsuccessful.

Tom Jarrett was not in agreement with the swale that was put on the property to re-route the water-shrubs are being ordered to be planted to help absorb some of the runoff water once this step is complete Mr. Jarrett should be able to sign off on the swale.

Lyle Washburn asked about the reassessment project, Supervisor Hall stated that is on hold and will not begin until the 2024 calendar year. Lyle stated his concerns with taxes and expressed his concern of being "taxed out" of his home. Supervisor Hall stated that he understood what Lyle was stating however, The Town has no control over assessment values placed on homes.

Barb Burch asked about the Hadlock Dam property that is in fact owned by the Town- at the previous board meeting (9/11/23) Supervisor Hall and the Town Board members were under the impression that the Town did not own any property around Hadlock Dam- they believed they only had a right away- and the property sold, however the new owner did agree to allow the Town to still use this as a right of way to the dam, but the new owners did take down the gate that was previously there, and due to the gate being down there have been more people that have been going down into the restricted dam area. Since the September meeting, this has been looked into further by both residents of the Hadlock area, Councilman Smith and Supervisor Hall and it was found out the Town in fact does own property around the dam and the Town is going to take the initiative of having a fence installed to keep people off of the dam for safety of themselves and the dam structure. Supervisor Hall did state that depending on the fence that is picked to be installed the Town may have to subcontract the installation of the fence out to another company.
