Supervisor Moore asked the board to take a look at the CASH ON HAND/FUND BALANCE at the very bottom of the right hand where it says increase in 2020 tentative budget is \$66,777.00 and the Town of Fort Ann Budget Summary 2020 bottom right of the first page also says \$66,777.00 matches.
