6:25 p.m. Open Public Discussion

Many Hadlock Residents were in attendance of the meeting due to a Facebook post that was shared by Brett Porter Jr. stating that the Town was encroaching on the Hadlock Residents rights and property and that if they wanted to be heard they should be in attendance at the Fort Ann Town Board Meeting

The issue that was brought up at the meeting was in regards to a short term rental dock space, the Moskos recently purchased a new property on Hadlock and the dock that came with the property is located in close proximity to the dam, the Moskos and Supervisor Hall asked the Town Engineers (Haley & Aldrich) who have been inspecting the dam since the dam was rebuilt after the 2006 dam break, if the current dock was compromising the dam in anyway, the engineers said if the Moskos were to follow the exact foot print of the dock that is there now but just replaced it, they did not see any concerns as to why this would compromise the dam in any way. If the Moskos were to install a completely different dock set up then at that point they would need to contact the APA and DEC to get the correct permitting, which the Moskos completely understand.

The Moskos have not determined what their next move will be as far as the dock space but will take any and all necessary steps to ensure they have the correct permitting and will not be compromising the dam in any way.

There was some back and forth with the Residents of Hadlock, the Moskos, and the Town Board, most of which happened due to misinformation that was given out to Hadlock Residents. It was established

that the Town is not taking anyone's rights or property from them and if there are ever any questions to please call the Town Hall, Town Supervisor or any Town Board Members to get accurate information and to have any and all questions answered.

Joan Degner did ask Supervisor Hall why the gate had been taken down; Supervisor Hall stated that the gate will be replaced in the spring.
