**Public Comment opened at 6:05 p.m.** Kristine Brown, 23 Paige's Way, Fort Ann stood to introduce herself and wanted to speak about paving Sly Pond Road to Hogtown Road. Supervisor Moore told her that her opportunity to speak would be later in the meeting.

## Public Comment closed at 6:06 p.m.

Supervisor's Report: Supervisor Moore stated he, Councilman Hall, Paul Winchell and Deb Donahue, Washington County DPW, met along with two (2) individuals from NYS DOT regarding Farley Road. It was recommended to check Farley Road weekly and keep a log. Paul Winchell will maintain the log. Next Spring from the edge of road go in 8' take off dirt and fill to take pressure off of the bank. They are of the opinion this can be done in a relatively short period of time. The engineers offered to give assistance. Supervisor Moore recommended to Councilman Hall that in February 2020 but no later than March 2020 get a bid from contractors and have contractor cut drains for water runoff. Supervisor Moore suggested Councilman Hall to get a hold of Washington County to see if there's grant money. Key people would be Laura Oswald, Senator Little's Office and Tracey Clothier.

Supervisor Moore received a letter from Army Corps of Engineers regarding a major replacement of a culvert on Rte 4. Should be taken care of between now and the year 2022.

Supervisor Moore received a letter regarding the dental coverage for the Town of Fort Ann and is pleased to report there is no increase in price through 12/31/2021.

Supervisor Moore stated there will be a special election 12/17/19 from noon to 8:00 p.m. at the West Fort Ann firehouse. Proposition 1 of 2019 is regarding West Fort Ann Fire Company current contribution of \$480.00 then \$800, then 1000.00 and third year out to \$1,200.00 (to be raised over three (3) years) and Proposition 2 of 2019 is regarding Pilot Knob Fire Company current contribution to be raised over three (3) years.

Supervisor Moore stated this is his last meeting as the Town of Fort Ann Supervisor. He thanked everyone. He stated it has been a pleasure to serve the public. He thanked all the appointed, elected officials and the employee's as well as the Attorney for the Town, Jeff Meyer. He wished everyone Happy Holidays!

Councilwoman Witherell thanked Supervisor Moore. She said he taught us how a Town Board should run.

Councilwoman Stark thanked Supervisor Moore.

Councilwoman Stark has information from the Office for the Aging.

Councilwoman Stark said that the annual Christmas in the Country seemed to be well attended despite the snow on Friday.

Councilwoman Stark stated there was Champlain Canal bike trail meeting held at the Fort Ann Town Hall December 3, 2019. She was glad that Councilman Hall was able to attend. They spent the afternoon mapping out various routes so people will have places to go. The bike routes are Kingsbury, Fort Ann and Whitehall.

Councilwoman Stark stated the annual ice fishing derby on Hadlock Pond will be January 11, 2020.

Councilman Hall attended an orientation today at Washington County Department of Public Safety.

Councilman Hall thanked Supervisor Moore for making this a smooth transition from Councilman to Supervisor. Councilman Hall stated Supervisor Moore has brought the Town of Fort Ann a long way over the last four (4) years as well as his presence at Washington County having a positive impact with his business expertise. Councilman Hall stated Supervisor Moore committed a lot of hours to the Town of Fort Ann.

Councilman Hall stated there will be a swearing in ceremony at the Town Hall January 1, 2020 at noon with refreshment served immediately following.

Councilman Fletcher stated he went to Home Depot where the couple, that were here last month's meeting, from Rocky Way that they should attend the Town of Kingsbury Town Board meeting about their concerns with Rocky Way.

Councilman Fletcher stated he is getting the run around from Washington Correctional and National Grid about the lighting along Route 22 in Comstock.

Councilman Fletcher stated it's been a pleasure to work with Supervisor Moore and he has had a calming effect on the Fort Ann Town Board.

**Open Public Discussion at 6:46 p.m.** Kristine Brown stated she was here with some of her neighbors about paving Sly Pond Road up to Hogtown Road. Supervisor Moore stated that the Highway Superintendent is not here tonight but he did ask him about this. He said several people have come to the Town Board over the last four (4) years looking for their roads to be paved.

The Town of Fort Ann has 73.55 miles of road and 28.8 miles is dirt and 47.7 is paved. Eighteen years ago blacktop was \$27.85 now it's 67.00. Could cost up to \$200,000 per mile. Getting money from New York State is a possibility. Councilman Hall said he will get back to the people of Paige's Way.

Kristine Brown asked for guardrails for safety purposes.

Councilman Hall will speak with the Highway Superintendent.

Councilman Fletcher will speak with Senator Little's Office.

Dale Grinnell thanked Supervisor Moore for starting the food pantry in Fort Ann. Word got out to the Queen Ann Senior Citizens, Fort Ann Central School and the food pantry is well stocked thanks to Supervisor Moore getting the word out to these different organizations and to the community.

Supervisor Moore stated he came across a picture of the food drive and it was heartwarming.

Daniel Snay, 24 Paige's Way, Fort Ann said he has pulled cars including mail truck out of the ditch because there is no cell service up in that area.

Arlene Green thanked Supervisor Moore. Supervisor Moore asked if the Old Stone House Library was considered an Historical Building. It is an Historical Building. Mrs. Green will get a number to Councilman Hall. Mrs. Green will be gone for the winter and wanted to make sure Councilman Hall continues making progress with the paperwork.

Supervisor Moore stated he was advised by the Charles R. Wood Foundation not to come back next year for more money for the Old Stone House Library.

Gene Connell thanked Supervisor Moore for his time and stated he has brought a lot of care and concern to the Town of Fort Ann. Mr. Connell stated Supervisor Moore has been a confidence builder.
