Supervisor's Report: Supervisor Hall stated he doesn't have much to report out on right now but something could come up as meeting moves along.

Councilman Sexton stated he finished reviewing the 2008 revitalization report. Councilman Sexton said the report of 2008 would be applicable in 2021 and going forward as a good base/foundation to build off of. The group that put it together in 2008 did a great job.

Councilman Sexton asked if the Town of Fort Ann should have a face book page. Supervisor Hall stated that the Town of Fort Ann does have a website. Michelle Vara does keep a face book page for the Town of Fort Ann and welcomes any information that people would like to have on the face book page.

Councilwoman Stark: Bike trail is completed up to Comstock. Recreation Committee is working on signage and ideas to get people to know what's going on in town.

Councilwoman Stark spoke to OC West and he's willing to be the Summer Recreation Director again this summer. Supervisor Hall stated that the Old Stone House Library wants to be involved with the Fantastic Friday's.

Councilwoman Stark stated that the Office for the Aging is delivering meals and meals are also available to caregivers. There are 2,000 frozen meals being stored at Golden Goal in case of an emergency like the power going out.

Councilwoman Stark stated that Joan Degener and Terry Barber are representing Washington County as Senior Citizens of the Year and will be honored in the FALL of 2021.

Councilwoman Stark stated that Fort Ann Central School Senior, Elizabeth Larli, appeared in the Teen Excellence section of The Post Star.

Councilwoman Stark stated the Senior Citizen Center, Oak Street, Hudson Falls, New York has reopened.

Supervisor Hall asked about training lifeguards and Councilwoman Stark stated she is working with Washington County Alternative Sentencing Director, Mike Gray, to find a location to train lifeguards.

Town Clerk's Report was given for February 2021.

Highway Superintendent Report: The Highway Superintendent said the trucks are up and running. They are cutting a few trees here and there. Trying to catch up from when they were sent home during that season. They are getting ready for road maintenance. Shelving Rock closed for at least another two (2) or three (3) weeks due to mud season.

Supervisor Hall stated that he heard from Kathy Robertson and she said she went on two (2) incredible hikes in Fort Ann (Sleeping Beauty and Shelving Rock).

Paul Winchell, Highway Superintendent, stated in years past the highway department did maintenance for Dacy Clearing and the Shelving Rock area (Friday work). Mr. Winchell asked the town board if they still want the highway department to participate in this. The Town Board agreed to continue this practice.

Enforcement Officer Report was given for February 2021.

Historian: Christine Milligan, not present, but stopped before the official start of Town Board meeting to update Supervisor Hall that Adam Nims is working on an Eagle Scout project. Supervisor Hall asked the Highway Superintendent to assist in any way that his department could.
