Supervisor's Report: Supervisor Moore announced that the annual sexual harassment training will take place at the Fort Ann fire house on April 18, 2019 from 10:00 a.m. – noon. Anyone receiving compensation from the Town of Fort Ann is expected to attend this mandatory training.

Supervisor Moore contacted the town's insurance carrier because after the recent high winds it was noticed that there were about 20 slate squares missing from the Town Hall roof. Supervisor Moore received a quote for approximately \$700.00 to repair.

Supervisor Moore stated that there will be Skywarn Training on May 1, 2019 from 7-9PM at the Washington County Municipal Center. If there is anyone interested in learning more about the weather and would like to help your community please see the Town Clerk for further information.

Supervisor Moore stated a Fort Ann resident recently stopped by the Town Hall to ask if he could use a metal detector at the library grounds and perhaps other properties that the town owns. The Town Board unanimously decided this was not a good idea and are not giving their permission to do so.

Supervisor Moore and the Fort Ann Highway Superintendent have had several meetings with Randy at Northern Trucking regarding the Harvester. Charlie Hildebrand was able to attend the last meeting on April 2, 2019. It was agreed to replace valve box, new hydraulic pump to keep temperature where it needs to be. Price to repair is approximately \$7,500.00 which includes parts, labor, hoses and freight. Another \$1,200 - \$1,300.00 for hydraulic fluid.

On motion of Councilman Hall, seconded by Councilwoman Stark for Supervisor Moore to authorize and execute any documents to repair the Harvester.

Motion was carried unanimously.

Supervisor Moore announced the Adirondack Triathalon being held May 5, 2019.

Supervisor Moore mentioned Casey Bush is painting four (4) historical signs along the roads of Fort Ann. All four (4) Bush sons (Cole, Caleb, Carter and Casey) have accomplished becoming Eagle scouts. Carter and Casey will be recognized at a future Town Board meeting.

Councilwoman Stark: Councilwoman Stark mentioned that the Office for the Aging nominated Senior of the year and there are two (2) chosen from Fort Ann (Arlene Green and Anthony Cantanucci).

Councilwoman Stark announced that there is an 8 session (April through June) free workshop series for seniors on journaling with a sketching component. The deadline is April 12, 2019.

Councilwoman Stark stated that Washington County is sending out a 2019 needs assessment survey to those over 60. The questionnaire will assist the Washington County Office for the Aging identify the needs for Community-Based Services. This information will help to plan future services and programs.

There will be a luncheon at the Old Stonehouse Library on April 16, 2019 and you need to call Pat Monahan for reservations.

Councilwoman Stark stated that the Canalway Trail is coming along from Fort Edward to Fort Ann. The state has cut trees and it's wide open and going to happen by summer of 2020.

Councilwoman Stark stated the summer recreation program will take place at the Fort Ann fire house rather than the school this summer. She stated she has three (3) lifeguards and will be having a meeting with them.

Councilman Hall: Councilman Hall announced that on April 27, 2019 at 10:00 a.m. the Fort Ann Rotary and the Fort Ann Town Board will be cleaning up the Waterfront Park. This will include cutting brush, pulling weeds, planting flowers, painting gazebo, etc. Any and all are welcome to participate in this annual event.

Councilman Hall stated that the grant papers have been sent to Mr. Caprood and this project is moving forward.

Town Clerk's Report was given for March 2019.

Enforcement Officer Report: Absent - paper copy of report was given to Town Board Member's for March 2019.

Dog Control Officer: Absent - paper copy of report given to Town Board Member's for March 2019.

Historian: Christine Milligan not in attendance but Dale Grinnell reported out that the painting of the signs has taken place by Casey Bush for his Eagle Scout project. Dale stated he was glad the town board voted no to using a metal detector on Fort Ann properties because if artifacts were found and touched/moved they lose their value.

Mr. Grinnell stated that the Red Cross will install three (3) free fire alarms. Supervisor Moore will call 518-694-5121 and get this information on the Town Hall bulletin board and town's website.
