Public Comment closed without comment at 6:05 p.m.

3.0 Reports from Town Officials and Committees:

Supervisor's Report: Supervisor Moore stated that on July 19, 2019 detour signs will be going up because Hogtown Road will be closed starting July 22, 2019 for at least 8-10 weeks while the Mount Hope project is underway.

On July 12, 2019 Supervisor Moore will be going to Pilot Knob Road with an individual from Washington County regarding parking and safety concerns. Supervisor Moore stated this is a difficult topic because some people believe that there should be no parking on both sides of Pilot Knob Road and some people believe there should be parking only on one (1) side of the road. Councilwoman Stark stated that parking has always been a problem at Pilot Knob. Supervisor Moore stated only 800' of Pilot Knob Road belongs to the Town of Fort Ann the rest belongs to Washington County.

Supervisor Moore stated he received a thank you letter from the Fort Ann Historical Society to the Fort Ann Highway Dept. on the pocket park timeline installation.

Supervisor Moore stated that NYS OFA announced two (2) Senior Citizens of the Year (Anthony Cantanucci and Arlene Green).

Supervisor Moore received a Public Comment Period Announcement for APA General permit/Order 2019G-1 for Replacement of Certain Utility Poles. Public comments will be accepted until 7/26/19.

On July 6, 2019 Supervisor Moore and Councilman Hall attended the annual Hadlock Association Meeting. The Harvester will be going in the water July 10, 2019.

Supervisor Moore stated that six (6) or seven (7) months ago most of the town money was moved from GFNB to NYCLASS for better interest. He stated this year \$13,154.97 has been earned in interest. He is anticipating approximately \$20,000.00 by the end of 2019.

Supervisor Moore announced that Councilwoman Witherell will be out of work for an unknown period of time so it will be necessary to appoint a temporary Deputy Town Supervisor. Supervisor Moore

stated Councilman Hall will be appointed by resolution effective 7/8/19. Supervisor Moore will be on vacation starting August 4, 2019 and he knows that Councilwoman Witherell is unavailable that date. Councilwoman Witherell will resume the role of Deputy Town Supervisor upon nofifying Supervisor Moore.

Councilwoman Stark: Councilwoman Stark stated summer recreation started July 1st.

Councilwoman Stark stated there was a groundbreaking ceremony for bike trail with officials from Washington County, New York State Canal Corp. and the Empire State Trail on June 20, 2019 at 11:00 a.m.

Councilwoman Stark stated the bike trail is coming along. It is unknown how much of it will be paved. She stated they are waiting on grants to continue with the trail from Comstock to Whitehall. She stated people are going to be looking for places to eat, rest, sleep, shop, bike repairs, etc.

Councilman Hall: Councilman Hall stated he and Councilwoman Stark will be attending an Ethics Seminar July 9 from 6:30 p.m. to 8:00 p.m. at the Milton Community Center that is being presented by the Association of Towns.

Councilman Hall spoke of Resolutions #87 Authorizing the Supervisor to sign documents to apply for grant through NYSDOS Local Waterfront Revitalization Program for Battle Hill Trailhead Project and #88 authorizing Supervisor to sign contract with the LA Group to prepare NYSDOS grant Application for Battle Hill Trailhead Project.

Councilman Fletcher: Councilman Fletcher stated he is working with Keith of Senator Little's office regarding the traffic challenges within the Town of Fort Ann.
