HYPER-REACH© COMMUNITY SIGN UP

Washington County, New York

The Washington County Department of Public Safety is re-launching our "Community Sign Up" program for our Hyper-Reach© mass notification system!

Hyper-Reach© is a mass notification system which operates utilizing the current 911 / landline phone databases that are used for identification purposes. During emergencies, the system allows public safety notification agencies to deploy mass notifications of landline phones and registered VOIP and mobile devices in a matter of minutes, getting the "urgent" message out to residents, businesses, or registered recipients of the selected area.

The first essential step in receiving the notifications in a time of urgent need is ensuring you, your family and friends, are signed up to receive the notifications if you do not have a valid landline telephone registered to your address in Washington County. Some VOIP (voice over internet protocol) phones will need to be added during the "sign up" process as well as all mobile devices.

You can sign up for free in just a minute by following these two short steps! Here's how:
