**RESOLUTION OF THE TOWN BOARD OF THE TOWN OF FORT ANN ELECTING DIRECT PAYMENT  
OF WASHINGTON COUNTY SALES AND COMPENSATION USE TAX ALLOCATION**

**WHEREAS** Washington County imposes sales and compensating use taxes pursuant to the authority of Section 1210 of the Tax Law of the State of New York; and

**WHEREAS** Washington County has elected to allocate a portion of the net collections from its sales and use taxes to the towns in the county; and

**WHEREAS**, Section 1262© of the New York Tax Law authorizes a town to elect to be paid all or a specified part of its share of the county's allocation directly, in lieu of reduction of county taxes and general town taxes levied upon real property in such town; and

**WHEREAS** the Town Board now desires to make such election;

**NOW, THEREFORE, BE IT RESOLVED**, that the Town of Fort Ann hereby elects to be paid directly all of its share of Washington County's sales and compensating use tax net collections, for calendar year 2024 and thereafter; and

**BE IT FURTEHR RESOLVED**, that, pursuant to such Section 1262© of the Tax law, a copy of this resolution shall immediately be mailed by certified or registered mail to the chief fiscal officer of Washington County and to the Clerk of the Washington County Board of Supervisors before November 17,2023 for this election to take effect January 1,2024; and

**BE IT FURTEHR RESOLVED** that this resolution shall be remain in effect until rescinded by the Town of Fort Ann Town Board in accordance with the notice provisions of such Section 1262 © of the Tax Law; and

**BE IT FURTEHR RESOLVED** that this resolution shall take effect immediately.
